## **EFMP OVERVIEW**

The Navy is enhancing existing EFMP special education services. Commander, Navy Installations Command (CNIC), in collaboration with Navy Judge Advocate General (JAG), is expanding special education support and legal assistance to families enrolled in the EFMP.

As part of the program, additional staff have been hired to include subject matter experts. This includes a Regional Special Education Liaison (RSEL) to provide special education support and advisement. This also includes a civilian special education/EFMP attorney to provide legal assistance to EFMP Families.

### NAVY REGION SOUTHEAST SPECIAL EDUCATION SUPPORT TEAM

## **NAVY EFMP CASE LIAISON (CL):**

- Provide information/referral services and non-medical case management.
- Provide a connection between military, local and national community resources and the EFMP families who utilize support services.
- Provide special education support related to Individualized Education Programs (IEPs) and 504s.

## **REGION EFMP SPECIAL EDUCATION LIAISON (RSEL):**

- Review IEPs and 504 plans with Navy families whose special education needs are beyond the scope of Fleet and Family Support Center (FFSC) EFMP CLs.
- Support Navy EFMP families with special education needs as it pertains to IEPs, 504 plans and associated plans.

## **NAVY REGION SOUTHEAST LEGAL SERVICE OFFICE CAN PROVIDE:**

- Provide IEP/504 eligibility, support, advice and consultation.
- Provide information on special education laws.
- Individuals with Disabilities Education Act (IDEA) support and understanding.
